1. Lilpoodles guarantees your puppy is in good health and free of hereditary defects at the time of purchase. Lilpoodles will provide a copy of the State-Licensed Veterinarian Puppy Exam. An official health certificate will also accompany each puppy that must ship by air. The buyer agrees to have their puppy examined (at the buyer's expense) by a licensed veterinarian within 72 hours of receiving the puppy. The buyer then has the right to return the puppy for an exchange if the puppy is found by a licensed veterinarian to be suffering from any serious illness or disease. Once the veterinarian provides a clean bill of health, however, it is understood that the puppy and his or her care are the sole responsibility of the buyer. This will end the 72-hour health guarantee. From the sale date forward, Lilpoodles will not be responsible for the health or wellbeing of your puppy.

Under NO circumstances will Lilpoodles be responsible for any injuries to the puppy after he or she leaves our facility.

2. Although we take precautions such as worming and vaccinating all of our dogs, we do not warranty against parasites or protozoans. The normal anxieties involved with changing environments can cause a puppy to become distressed. This stress will sometimes result in runny stool and can occasionally cause the dormant, ever-present coccidia protozoa to become active. This is especially common with long drives or airplane flights, and we warn everyone about this. We will not consider these sorts of issues (including but not limited to coccidiosis or hypoglycemia) as grounds for refunds or replacement puppies.
3. This puppy is being sold with Full AKC Registration Limited AKC Registration
(If limited registration is checked, the puppy may not be used for breeding purposes. No offspring from such dogs are eligible for AKC registration, and we recommend spaying or neutering the dog at the appropriate age.)
4. The buyer agrees to maintain the puppy in good condition. This includes adhering to a regular immunization schedule, a heartworm preventative program, a good diet, and good grooming habits. The buyer also agrees to provide the puppy with clean/safe living conditions. No puppy shall be sold to anyone who does not intend to raise the puppy indoors.

5. If at any time in the puppy's life the buyer decides to sell or give the puppy away, the buyer shall so notify Lilpoodles and give us the first option to buy back the puppy or include him or her in our free puppy rescue program.
6. The buyer agrees not to sell the puppy or the puppy's offspring to any individual or establishment in the business of buying and selling puppies for a profit (e.g. pet shops, puppy mills, or online puppy brokers).
7. Lilpoodles provides a one-year Genetic Guarantee, as follows:
 - Any and all problems found with this puppy must be proven and diagnosed through a licensed veterinarian. Sometimes, a second opinion may be required.
 - We offer a one-year guarantee against any life-threatening congenital diseases to our puppies. This applies to the first full year of the puppy's life. If problems should arise, the buyer must notify us within 14 days of the health issue's initial diagnosis in order to validate this warranty.
 - If the puppy should lose its life due to a congenital illness, a veterinary-managed necropsy must be done immediately to determine the cause of death. If the death was caused by a breeding fault, we will stand behind our dogs 100% and provide the buyer with a 100% credit toward a new, replacement puppy of their choice. If the replacement puppy is of lower value, Lilpoodles will refund the difference. If the replacement puppy is more expensive, the buyer agrees to pay the difference. Lilpoodles will pay up to \$285.00 freight to replace a puppy under our Genetic Guarantee.

By signing this contract, the buyer is entering into a sales contract and is therefore bound to this agreement.
